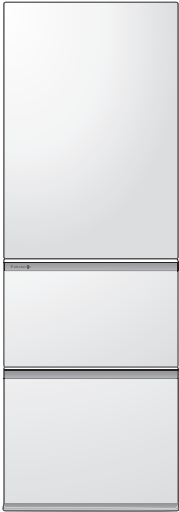

移動雪櫃時：

使用須知

打開/關閉雪櫃門時：

- 切勿存放比托板或托架大的物品，否則雪櫃門將無法關緊，從而導致冷氣洩漏。
- 切勿頻繁打開雪櫃或長時間打開雪櫃，以防雪櫃內部形成水滴，造成能源浪費。
- 經常檢查雪櫃門密封膠條，其必須與雪櫃機身完全貼合。

清潔時：

- 切勿使用化學物質或液體清潔雪櫃。這些物質會損壞和腐蝕雪櫃表面。



使用須知

使用時：

- 拔下電源插頭後，請等待 7 分鐘後再插上。否則，可能會導致壓縮機停止運作。
- 根據實際運作情況調節溫度，以節約能源。
- 每個間室外殼內的濕氣可能會凝結，因此請定期用布片擦拭。每月清潔一次外殼。
- 如果您將外出幾天，且雪櫃裡沒有儲存任何物品，應拔下插頭以節約能源。雪櫃幾天不使用時，需要將雪櫃內剩餘的食品全部取出，清潔雪櫃並打開雪櫃門幾個小時，讓雪櫃內的水分乾燥，避免部件發霉和氧化。
- 雪櫃機身外壁有時可能會發熱，尤其是在剛剛安裝後。這很正常，這是因為內置了門框乾燥管來防止水汽凝結和散熱。
- 當濕度較高時（例如在雨季），雪櫃機身外部可能有水汽，特別是在櫃門密封條周圍。請用乾淨的布片擦掉凝結的水汽。
- 切勿長時間打開雪櫃門，特別是在炎熱潮濕的天氣。
- 雪櫃頂部由鋼製成，以防外部影響引起的火災。切勿在雪櫃頂部放置物品以確保這一因素。



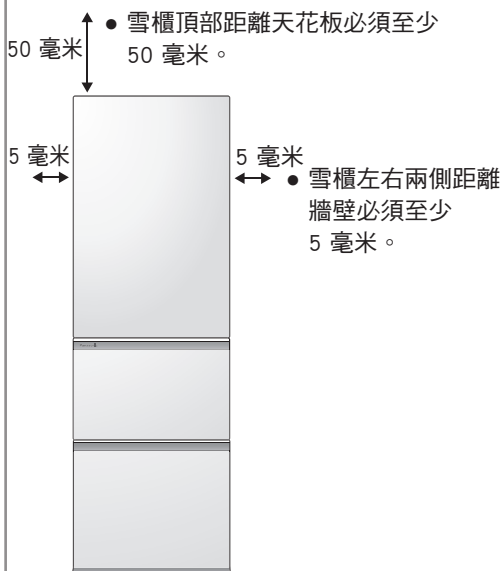
儲存食品時：

- 切勿將熱燙食品放進雪櫃。
- 將熱餸放入雪櫃之前，先在室溫下冷卻。
- 切勿在雪櫃內放置過多物品。食品之間必須留有間隙，以保持冷卻效果。
- 將水果和蔬菜儲存在蔬果室中，這裡的濕度較高，能令食品長時間保鮮。
- 飲用水、飲料瓶應密封，以防止異味污染。
- 將蔬菜、水果及生鮮食品等食品放進雪櫃冷凍或冷藏前，應使用保鮮紙包好或放入保鮮盒中。
- 需要長時間儲存的肉或魚等食品應放入冷凍室(Freezer)。
- 用密封蓋、塑料膜或箔片蓋住多汁食品。



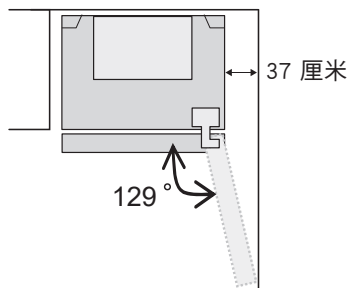
安裝

安裝距離要求



小心

- 如果雪櫃靠近牆壁安裝，必須確保雪櫃右側與牆壁之間的距離至少為 37 厘米。如果這個空間不夠 37 厘米，門可能無法完全打開，玻璃托板、蔬果格等可能無法取出。



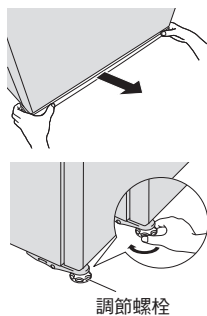
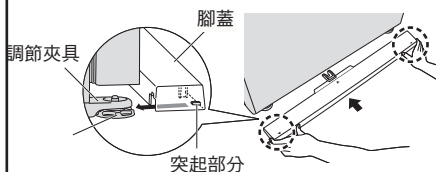
- 初次使用時，請清潔雪櫃內部。
- 使用柔軟的濕布清潔雪櫃。
- 沖洗儲水箱和濾水器。
- 初次使用雪櫃時可能會聞到塑料的味道。如果味道比較濃烈，建議給房間通風。
- 切勿將雪櫃放置在潮濕的地方，因為這樣容易生鏽，並可能致漏電。
- 切勿將雪櫃放置在陽光直射的地方，因為高溫 and 陽光會使雪櫃溫度上升，影響製冷效果。
- 切勿將雪櫃放置在廚灶或烤箱等熱源附近。
- 切勿堵塞雪櫃周圍的空間。
- 雪櫃必須放置在空氣流通的位置。
- 如果要將雪櫃放置在不平坦的表面上，請調節一下調節螺栓，以確保雪櫃穩固。

固定雪櫃。

- 1 拆下腳蓋。雙手插入腳蓋兩側的「↓」下方，將其拉出。
- 2 旋轉調節螺栓（右側和左側）直至其接觸地板，以使雪櫃保持平穩。
- 3 重新安上腳蓋。

- 如果雪櫃安放不平穩，開/關雪櫃門時會出現敲擊聲（這不會影響雪櫃的工作性能。）

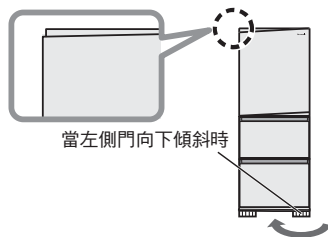

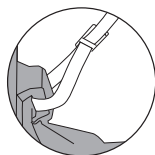
旋轉較低側的調節螺栓即可調整平穩，如右圖所示。

- 雪櫃安裝四五天後，由於裝載食品或對地面的適應，冷藏室(Fridge)門也可能會發生傾斜。在這種情況下，用專用工具轉動相應的調節螺栓，重新調整並調平雪櫃門即可恢復。



是否已採取措施預防地震時出現傾側？

為避免雪櫃傾側，請使用固定帶等物件將其永久固定。



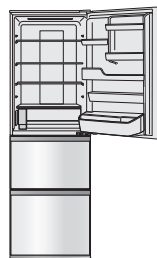
內部冷卻過程中不得打開雪櫃門。

在內部充分冷卻之前不得打開雪櫃門。

（熱空氣流入內部會影響冷卻功能。）

請等待內部充分冷卻。

- 在內部空載且門未打開的情況下，雪櫃可能需要連續運作至少 4 小時才能使內部充分冷卻。
- 根據環境溫度和使用條件，可能需要 24 小時才能使內部充分冷卻並達到平衡。



安裝

LED 燈和接地

- 雪櫃內 LED 燈專為本雪櫃設計，不得自行更換。如需更換，請聯絡 Panasonic 服務中心。
- 如果雪櫃插頭沒有接地線，應接好接地線，以防漏電造成觸電危險。

移動或轉移

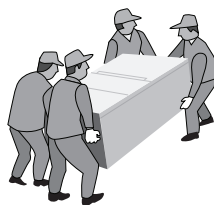
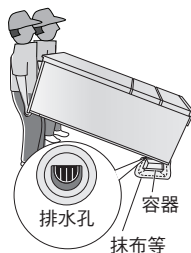
- ① 取出所有食品，處理掉雪櫃中殘留的所有冰塊或水。
- ② 拔下雪櫃插頭。
- ③ 調節一下調節螺栓（左側和右側），使其接觸地板。
- ④ 在雪櫃背面底部的排水口下方放一塊抹布或類似物品，並在上面放置一個容器（高度不超過 2 厘米），然後慢慢向後傾斜雪櫃，從排水口中排出水。

※如何移動及搬運

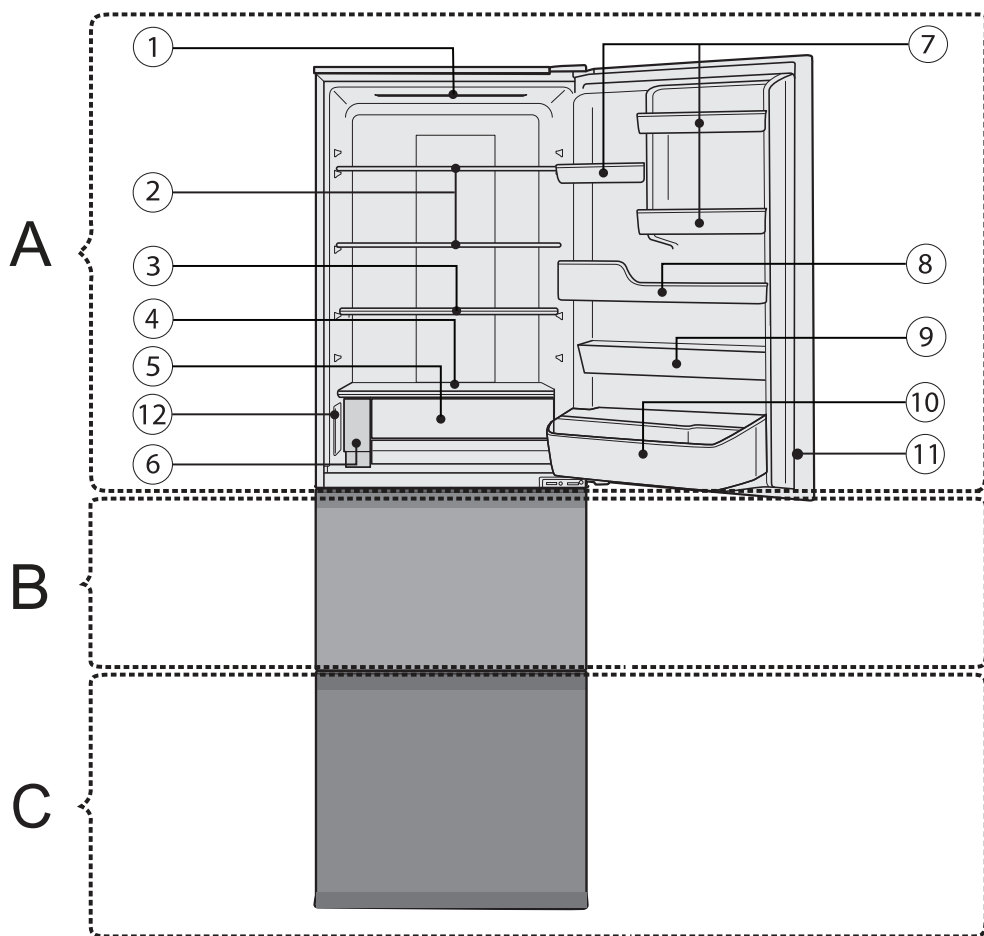
- 搬運雪櫃至少需要 2 人，且不得水平堆放。（這可能會導致人員受傷或設備故障。）
- 每個人抬起雪櫃的一角。
- 搬運時切勿抓住雪櫃門。

注意

- 搬運時，用綁帶固定雪櫃門，避免雪櫃門自行打開。
- 搬運時切勿將雪櫃側放，否則可能會損壞雪櫃。
- 安裝完畢後，至少等待 4 小時再插上電源，確保壓縮機內的氣和油處於穩定狀態。

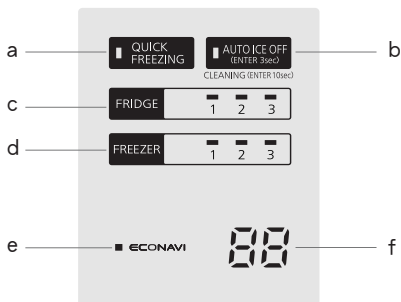

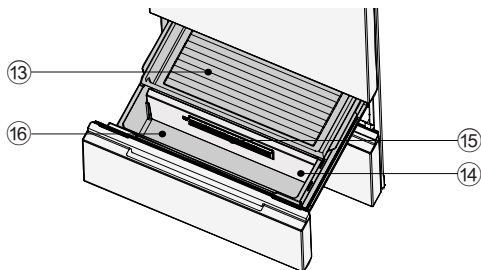

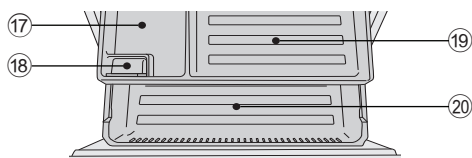

溫度控制

溫度可調節為「1」-「3」級。按下「Freezer」即可調節冷凍室(Freezer)溫度，按下「Fridge」即可調節冷藏室(Fridge)溫度。

「1」	比「2」約高 2 °C ~ 3 °C	比「2」約高 2 °C ~ 3 °C

一般情況下，使用雪櫃時將溫度設定為「2」。

- 雪櫃內部溫度會因環境溫度、安裝狀態、使用條件和食品儲存量而有所不同。
- 本雪櫃配備了處理器來控制內部溫度。當環境溫度發生變化、壓縮機運轉或停止運轉、打開或關閉雪櫃門時，雪櫃內部溫度與設定的溫度會有細微的差異。

微調模式

本雪櫃經特別設計，旨在滿足各種用途，可調節溫度細分為 9 個等級，詳情如下。

如何操作微調模式

冷藏室(Fridge)

- 使用「Fridge」按鈕將 LED 顯示設定為「1」。
- 按住「Fridge」按鈕（10 秒），直至 LED 顯示回到「1」的位置。
- 按下「Fridge」按鈕，設定下表提到的「9 級」模式。

冷凍室(Freezer)

按下「Freezer」按鈕（而不是「Fridge」按鈕）操作上述 ① ~ ③ 步。

重設微調模式設定

重複步驟 ① 和 ②，然後雪櫃會恢復正常運作模式。

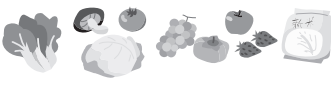

儲存位置	溫度建議	食品加工目的及推薦食品
冷藏室 (Fridge)	3 °C ~ 6 °C	「食品 and 飲料……」 用於常規儲存食品和飲料或 暫時儲存即時需要的食品和 飲料。 
冰溫室	0 °C ~ 2 °C	「加工食品……」 用於儲存加工食品、冷藏食品等。 
蔬果室	3 °C ~ 8 °C	「水果和蔬菜……」 濕度較高，便於保持水果和 蔬菜新鮮多汁。 
冷凍室 (Freezer)	-20 °C ~ -18 °C	「長時間儲存食品……」 用於儲存冷凍或乾燥食品。

ECONAVI 智慧節能模式

雪櫃透過偵測門的打開和關閉來自動控制操作，以確保節約能源。^(*)

■ ECONAVI 操作

- 雪櫃會不斷學習您家庭的生活方式，包括開門頻率和平常使用的時段，以最大限度地提高能源效率。
- 雪櫃會根據前 3 週的使用情況學習您的生活方式，然後從第 4 週開始使用這些數據。

■ 啟用 ECONAVI 操作的設定

- 當冷藏室(Fridge)和冷凍室(Freezer)的溫度控制等級分別設定為「2」時，ECONAVI 操作會自動啟用。
- 如果正在執行快速冷凍模式，則 ECONAVI 操作不會執行。
- 無法強制啟動 ECONAVI 操作。

備註

^(*) ECONAVI 操作的有效性取決於環境溫度、開關雪櫃門的次數以及食品的儲存狀態。

快速冷凍模式 (Quick Freezing)

設定快速冷凍模式(Quick Freezing)後，雪櫃會迅速降溫，以更好地保存食品，並加快製冰速度。

■ 如何操作快速冷凍模式(Quick Freezing)

自動製冰停止模式 (Auto Ice Off) 和自動製冰清潔模式 (Auto Ice Clean)

當雪櫃處於運行狀態時，自動製冰模式(Auto Ice Off)將自動執行，無需任何設定。當設定自動製冰模式(Auto Ice Off)和自動製冰清潔模式(Auto Ice Clean)時，雪櫃將停止自動製冰，並自動清潔自動製冰機。

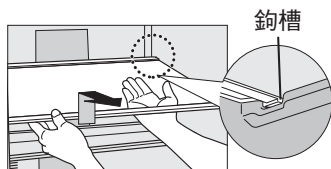

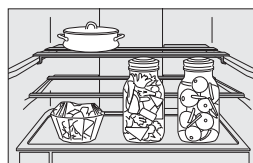
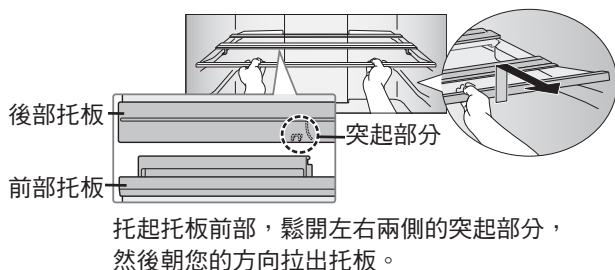
冷藏室(Fridge)玻璃托板的位置可以改變

- ① 將玻璃托板的背面邊緣從兩個鉤槽中托起，然後向前滑動玻璃托板。
- ② 向後滑動玻璃托板，然後將其放在鉤槽中。
 - 玻璃托板有一定重量。請小心拿取，避免掉落，以防造成任何損害或傷害。

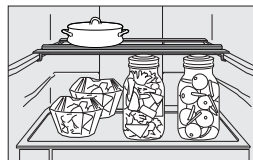


1-2 玻璃轉盤

食品儲存小貼士

■ 切勿囤積過多食品

當食品過多，雪櫃內部沒有空間供冷氣循環時，製冷效果就會受到影響。冷藏室(Fridge)內儲存的食物之間要留有足夠的空間！

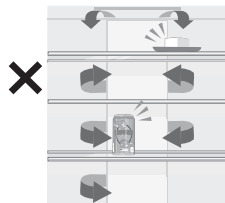


不浪費雪櫃內的冷氣是長時間保持食品新鮮的關鍵！

■ 切勿讓食品堵塞冷氣出風口

如果冷氣未擴散到冷藏室(Fridge)的每個角落，雪櫃內部就無法充分冷卻，並且會消耗更多電力。因此，切勿將食品放置在冷風口^(*)前，以免影響雪櫃內的空氣循環。

^(*) 冷風口位於冷藏室(Fridge)內部的管道上。

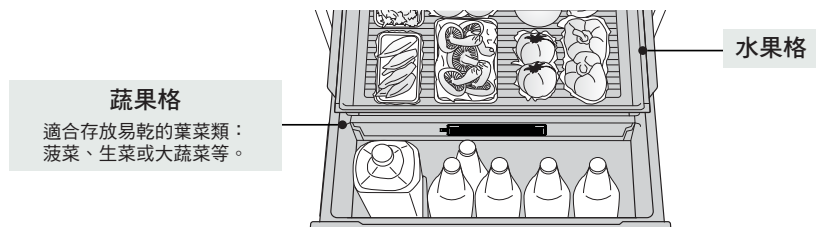


蔬果室

蔬果室採用大容量設計，並配備可打開最大角度的導軌，以便拿取食品，並增加了其承重能力，使用者可單手輕鬆將其拉出。

將儲存在蔬果室的蔬菜 and 水果用保鮮膜包好，以防變乾。

如果您想在夏季保持啤酒瓶涼爽，我們建議將其存放在冰箱中。



備註

- 由於濕度較高，蔬果室內可能會出現水滴。用軟布擦去水滴。
- 切勿儲存高於蔬果室高度的食品，以免蔬果室無法關緊，從而導致結霜，損壞蔬菜和水果。

小貼士

對於建議常溫保存的蔬菜和容易發生低溫損壞的食品，請選擇儲存方法和儲存位置，如儲存在陰涼避光處，或在食用前放入雪櫃冷藏。



- 南瓜、番薯、洋蔥
→ 放在陰涼避光處



- 蔬菜：豆角、茄子、黃瓜
- 水果：香蕉、芒果、牛油果
→ 食用前冷藏一小段時間。
